Aaron Kannedy last Will proven at May term 1845
In the name of God amen I Aaron Kannedy of Surry
County being of sound and perfect mind and memory do
by God do this fifteenth day of February in the year of our
Lord one thousand eight hundred and forty four make and
publish to this my last Will and testament in the manner
following &c After all my just debts is paid I wish
I give and bequeath unto my beloved wife Temperance
Kannedy one hundred dollars out of my estate for her support
after my death to be paid over to her as soon as the money
can be collected according to law which is to be her
part of my Estate left in the hands of my Executor to
be hereafter appointed I then I give and bequeath
unto my beloved Daughter Jane Roberts and the heirs of her
body one Negro Woman named Hecker at four hundred dollars
it being part of my Estate belonging to her I then I
give and bequeath unto my beloved Daughter Fiebel Daynes
and the heirs of her body one Negro woman by the name
of Temperance at four hundred dollars it being part of my
Estate coming to her I then I give and bequeath unto
my said Daughter Aphana Poor one hundred dollars

act of my testator to be paid by my Executor and that is to be
his part of my Estate. Fourth I give and bequeath unto

Harrison Kainer my grand son one hundred dollars out
of my Estate and that is to be his part of my Estate to be

Fifth I give and bequeath unto my grand son David Weston
the son of my daughter Sally one dollar and no more

Sixth I give and bequeath unto Elizabeth Popwell and the heirs of
her body one dollar and no more. The balance of my property

viz lands with the exception of one hundred acres more or less

that I give unto Ruffin Kennedy with all my regard that is
not given off in my will with all my lease property houses

hold and kitchen furniture to be sold on a credit of twelve
months and as soon as the money can be collected and the

several sums paid to the different persons as specified in my

will the the money to be paid out unto James Roberts & Thomas Douglas
or the heirs of their body until they have received as much

as my son John Kennedy who has received eight hundred and

sixty five dollars for which I have his receipt for then James Roberts &
Thomas Douglas and John Kennedy is to be made equal to my son

William Kennedy who has received nine hundred and sixty five

dollars for which I hold his receipt for then the balance of the

money of any to equally divided between James Roberts, Thomas

Douglas, John Kennedy & William Kennedy and I hereby make

and obtain my worthy friend Elizabeth Thompson Executor of her my

last will and testament in witness whereof I the said James

Kennedy have to this my last will and testament set my hand

and seal this day and year above written
