


In the name of God. Amen. I William B. Kennedy of  
the County of Wilkes in the State of North Carolina  
being weak in body but of sound and disposing mind  
and memory do make and publish this my last  
Will and Testament in manner and form following  
to wit,

I hereby will and bequeath to each of my  
children hereafter named and my wife Rachel  
Kennedy equal portions of all and singular  
my Estate both real and personal to be ascertained  
by sale of my property and giving to each my  
Legatee one share except that the property hereto  
fore given and advanced to my children is to  
be subtracted from the share of each so as to  
make all equal including said advancements.

I direct my my Executor hereafter named  
after my decease to sell all my property on a  
reasonable credit, to collect all debts due me  
and pay all my just debts and pay to my  
wife Rachel one equal share with all my  
Children To Ruffin Kennedy one share except  
that the following advancements be added to  
the amount of my Estate and be subtracted  
from the share of each of my Children.

To Ruffin Kennedy I have advanced Seventy five  
Dollars To my daughter Sedilia Seventy Dollars.  
To my daughter Mary Thirty Dollars - To my Son  
Williams Two Hundred & forty Dollars To my Son  
Thompson One Hundred & forty Dollars To my  
Son Horwood Two Hundred Dollars. To my daughter  
Millia Twenty five Dollars. And it is my will  
that the Advancements made shall be rated at the  
above figures.

And my will is that my executor shall pay over to each of my children their part of my estate except Sedillia. my will is that my executor shall keep Sedillias part in his own hands and advance it to her by little portions according to his judgment for the support of her and her children  
Lastly I hereby appoint my son Norwood Kennedy executor to this my last will and testament  
In witness whereof I have hereunto set my hand and affixed my seal the 5<sup>th</sup> day of October in the year of our Lord one thousand eight hundred & sixty 1860

for said County, Sept 5<sup>th</sup> 1874
